FLU SEASON

(National Quality Area 2: Children's Health and Safety)

Preventing the spread of influenza Flu can be serious for children, especially children under five years old. As early childhood education and care providers, you play an important role in protecting children, colleagues, families and communities from influenza. Do your parents and families know that the flu vaccine is free to children aged between six months and under five years?

Changes to Gap Fee Payments from July 2023

As you are aware the new Family Assistance Legislation has come into effect. This legislative change introduced important measures to strengthen payment integrity and ensure that services are meeting their obligation to ensure that a gap fee is being paid and therefore that every session of care claimed has a genuine liability. Services must have in place adequate systems of oversight to ensure the gap fee is being paid.

What has the Service put in place?

- Informed all families of the change and their requirements.
- Have received a Fee Payment
 Declaration from all stakeholders. This will continue with all new stakeholders in the future. (Please ensure the current vision of the enrolment form is always used as this is now included.)
- We encouraged all Educators to consider opening a business-only bank account. This will allow Educators to keep personal and business bank records separate.
- Our July visits will be recording your invoicing and receipting process and how your records can be sighted.

This information will be recorded and from there any further requirements can be built into this process.

Again, our aim is to be able to make this new requirement as unobtrusive as possible. It will NOT be our aim to look through your personal banking but as always, we will ensure the Service and Educators are meeting all Government requirements.

Administration Update:

Reminder, the Service Levy to the parents was increased from the 3^{rd of} July to \$1:45 and the CCS Family Day Care Cap was raised to \$12.72 per hour, (any amount charged over \$12.72 will be at full fees)
